Nickel chloride (7791-20-0) 3% or less and Water (7732-18-5) 97% or more.

SECTION 3 — HAZARDS IDENTIFICATION

Green aqueous solution. Odorless.

Solid nickel chloride is a known human carcinogen by inhalation of dust (IARC-1).

Moderately toxic by ingestion. Irritating to skin. Avoid all body tissue contact.

SECTION 4 — FIRST AID MEASURES
